PRIMARY CANDIDATE FORUM ON JULY 22 BALLOT ISSUES FORUM ON JULY 24



Candidates in the August primary races will be featured in a Tuesday, July 22 forum in the Friends Room at the library at 6:30 p.m., with refreshments at 6:00 p.m.

The July 22 forum features primary candidates in the races for 47th District Representative, Boone County Recorder of Deeds, and Division 5 Associate Judge. Candidates running unopposed for county offices and the state legislature will not be included in the forum. The proposed 1/8 cent county sales tax for the fairgrounds will also be covered. KFRU's David Lile will moderate the forum and it will be broadcast live on KFRU radio.

Our Ballot Issues Forum will be Thursday, July 24th, in the Friends Room at the library at 6:30 p.m., with refreshments at 6:00 p.m. The August primary ballot will include five proposed constitutional amendments: the so-called "Right to Farm" measure; an amendment that concerns the people's "right to be secure in their electronic

communications and data from unreasonable searches and seizures"; an amendment that creates a "Veterans Lottery Ticket" to raise funds for projects and services related to veterans; an amendment that would declare the right to keep and bear arms as an unalienable right that the state must uphold; and a three-quarters of a cent sales tax to fund state and local highways, roads and bridges. We will try to find pro and con speakers on all issues; if we cannot find speakers, we will provide pro and con information.

Candidate and ballot issue forums for the November general election with be held in October. The state issues on the November ballot include early voting, allowing lawmakers to override gubernatorial budget cuts, and permitting evidence about prior criminal acts to be used against people facing prosecution for child sex offenses.

JULY 9 CAT TV FEATURES NEW BUS SYSTEM: COMO CONNECT

The LWV will present a CAT-TV program on Wednesday, July 9th at 7:00 p.m. that highlights the city's new bus transit system -- CoMo Connect. The new transit system will begin operations on August 4th. CoMo Connect will replace the current hub-and-spoke bus transit system with a north/south, east/west interlinking transit system. CoMo Connect will increase the area covered by the City's transit system and will allow more flexibility for riders.

Guests on the July 9th program will be Drew Brooks, Multi-Modal Manager for the City of Columbia, and Ian Thomas, City Council Representative from the 4th Ward. The program will be moderated by Randy Picht, Executive Director of the Reynolds Journalism Institute.

CAT TV can be found on Mediacom Channel 85, Charter Communications 983, and CenturyTel Prism 98. The program will be available on our website a few days after July 9th or at www.columbiaaccess.tv. The replays on CAT TV are at 7:00 a.m. on Tuesday, Thursday and Saturday and 7:30 p.m. on Monday, Wednesday, Friday and Sunday.

The LWV Board met on June 23. We had 15 Board members in attendance, including Liz Schmidt, who moved that day!

The Board was updated and made decisions on many upcoming events:

The Fall Kickoff Picnic will be on September 9th at Bethel Park. Each Board member will contact a new member and invite them to come. The picnic will begin at 5:30 p.m.

On October 18th we will have a special CAT TV show. Rachel Brekhus has confirmed that Dr. Aaron Astor, author of Rebels on the Border, will talk on the post Civil War period in border-states like Missouri.

Our Founder's Luncheon will be our 95th Anniversary, so we would like a nice venue. We have a committee working on the details for a November date and location.

Our new Lunch and Learn regular program will be on the third Wednesday at the Grindstone Hy-Vee meeting room (except September will be the fourth Wednesday) through December. We need to look at the available technology to determine the fall programs.

The Board decided to participate in the Boone County Council on Aging Lifestyle Festival on

LWVUS NATIONAL CONVENTION HELD IN DALLAS JUNE 6-10

Decisions made at the 2014 LWVUC National Convention included the following:

- President Elizabeth McNamara won reelection.
- The PMP (per member payment) will remain \$31 for 2015 and go to \$32 for 2016.
- Concurrence with LWV New Jersey on Human Trafficking was passed. Our local League had recommended this action.
- A floor concurrence with LWV Kansas on Living Wage failed to pass with a 2/3 majority. There were issues with the language and the detail of the position.
- Studies on economic inequality and a revision of the ag position were defeated. Mostly these failed to pass, because we already have a lot on our agenda.
- Resolutions Climate Change and Campaign Finance resolutions passed. The Campaign Finance resolution urged the board to act quickly on this issue as part of the three-part program approved.

A comprehensive three-part program was approved, however we do not know how that will translate into studies for local Leagues. They estimated maybe one study in 2015-16 on one of the following topics:

- Study the process of amending the U.S. Constitution, including constitutional conventions. (There are efforts to pass a Constitutional Amendment to correct the Citizens United ruling among other issues and the national board wants to make sure any wording does not result in unintended consequences.)
- Review and update position on campaign finance.
- Review the redistricting process for U.S. Congress. (There is already an operating task force on this issue.)

There is a new Young People's Task Force and an amendment to the budget added a Minority Task Force. There was a general sense that the League needs to be more diverse.

Missouri had 17 delegates and there were 645 voting delegates nationally. Forty-seven states were represented as well as Puerto Rico and Washington, D.C.

There were several interesting speakers and many workshops. The Columbia delegates will each write an article about their experience; two are on the next page.

My Convention Notes, Peggy Placier

The <u>Young People's Task Force</u> session was packed. We need to use different strategies to recruit younger members and keep LWV vital. They distributed a toolkit, which is available on the LWVUS website. What should MO do? We need to be conscious of how often we say, "We've always done it that way," and think about the accessibility of our meetings/events for students, working women and mothers/fathers.

Voter Protection is a big issue in 23 states. In SC, arguments for voter ID focused on fraud and "dead" voters, both without credible evidence. LWV joined others to oppose this under "reasonable impediment" language of the Voting Rights Act. Department of Justice supported them but Supreme Court recently struck down parts of VRA. FL has seen multiple forms of voting law manipulation. 2012 election was "embarrassing" due to long lines. LWV sued over voter registration limits and won, but early voting was cut so the long lines persist. What should MO do about early voting? Will voter ID return?

The <u>Climate Change</u> session proposed a network of local leagues with an interest in their local climate and water issues. Message: Focus on what people "treasure" about a place, show impacts through stories, emphasize actions people can take. Include this issue in candidate forums. What does Missouri stand to lose?

FL, MN, WA, and NY reported on school choice and the big money behind it (private and government). FL LWV got press attention with a state report critical of charters. LWV in WA joined a fight to stop charters as unconstitutional (based on state constitution language prohibiting public funding of private schools). NY focused on tax credit scholarships and their resegregation effects. ALEC provides the model language on these to state legislators. The caucus attendees have started a blog for sharing articles and info. In MO we are tracking this issue and tax credit scholarship issue.

MA state league urges that we look at money in politics. Materials are on the LWVUS website and LWV Minnesota site. Goal: a Constitutional amendment on campaign finance. In MO we should look at the 501c4 issues with private groups. Could we do a study of the flow of private money into MO elections and politics?

My Convention Notes, Diane Suhler

One of the best sessions I attended was on the election process. Dr. Mark Jones of Rice University discussed the impact of majoritarian voting systems, limited/cumulative voting systems and proportional representation voting systems on the number of women and minorities elected to office, on gerrymandering, on groups being underrepresented by elected officials, and on money in politics. The U.S. is one of the few countries with majority voting; a move to proportional representation would fix a number of the problems in our political system.

Professor Stephen Murdock of Rice University spoke on <u>US demographic trends</u>. He is concerned that education is leaving the Hispanic groups behind. As the proportion of Hispanics in the US population increases, the future of the U.S. will be tied to how well this group does economically, politically, and socially.

The Help America Vote Act of 2002 was the first time the Federal government has provided funding to state and local governments to run elections and to modernize elections procedures. The main functions of the Election Assistance Commission (EAC) are to ensure that voting systems used in elections are certified to guarantee the integrity of the voting machines and ensure that data collection is accurate. Four key recommendations from the EAC: 1) Support online voter registration; 2) Exchange voter registration databases among states; 3) Provide for registration at motor vehicle registration places; and 4) Allow for voting prior to election day.

One of the highlights of the convention was the talk presented by Mayor Annise Parker of Houston. I saw her as a female version of Bill Clinton. She did a wonderful job of highlighting the skills needed to be the mayor of a large city and the demands of such a position.

Another caucus session that I attended was "Don't Drink the Water: Protect Your Water from Chemical Spills." This session focused on various types of tanks that hold chemicals that often are not inspected regularly and can leak resulting in toxic chemicals being leaked into the environment.


