# HOLLY BURGESS PUBLIC POLICY FORUM OCTOBER 29: ARE OUR ELECTIONS SAFE?



We hear in the news that there are concerns related to the security of elections in the U.S. Have elections in some states been hacked by outside forces? Could that happen here? Are the voting machines safe or do they need to be updated? These and other questions will be the subject of a public forum on Sunday, October 29, 2017 at 2:00 p.m. at the Columbia Public Library.

A panel consisting of Taylor Burks, Boone County Clerk, and Glenn Nielson, a computer expert, will

discuss the subject of election safety. There will be opportunity for Q&A with the audience.

Taylor W. Burks was appointed as Boone County Clerk by Missouri's Governor following the retirement of longtime Boone County Clerk Wendy S. Noren. Taylor worked for US Congressman Bill Thomas, Chairman of the US House Committee on Ways and Means, and later for Missouri Senator Jack Goodman, (continued on page 3)

## PLEASE SIGN THE CLEAN MISSOURI INITIATIVE PETITION

The Clean Missouri ballot issue is a constitutional amendment by initiative petition and supported by the LWV. Signatures are being collected now and we encourage you to sign the petition. This measure has several features that are high priorities for the LWV:

- Ethics in Government: eliminate most lobbyist gifts to state legislators; require politicians to wait two years before becoming lobbyists; and lower campaign contribution limits for state legislative candidates.
- **Open Government**: require that legislative records be open to the public.

• Fair Legislative Districts: ensure that neither party is given an unfair advantage when drawing new legislative maps after the next census (2020) and all other censuses; add fairness and competitiveness as criteria; and ask an independent state demographer to lead the technical work on new maps.

In 2002 he served on a special committee formed by the Missouri Secretary of State to make recommendations for implementing election

process changes to comply with the Help America Vote Act.

This forum honors the memory of Holly Burgess, a member of both LWV and AAUW, who was particularly interested in public policy issues.

## **ELECTION INTEGRITY COMMISSION UPDATE**

On May 11, 2017, President Trump issued an executive order establishing the Election Integrity Commission, headed by Vice President Pence and Kris Kobach, the Kansas Secretary of State.

As we reported in the September *Voter*, League of Women Voters president Chris Carson issued the following statement in response to the first meeting of the 'Election Integrity' Commission: "This Commission is undermining the public's confidence in our elections."

Recently, the Commission met a second time (September 12th ) in New Hampshire. And, on September 12th both the St. Louis League of Women Voters and the Kansas City League of Women Voters joined other groups to publicly voice their opposition to the Commission stating their concerns that the

Commission will ultimately support "inflexible voter ID laws, reduced polling sites and inadequate poll worker training, and request voter data". Furthermore, the STL and KC LWVs state they believe the commission's actions have the potential of federal interference in state election laws.

### FROM GERRYMANDERING TO FAIR REDISTRICTING

What do U.S. citizens want with respect to redistricting? Do they care about how voting districts are configured?

A poll was conducted by Democratic pollster Celinda Lake of Lake Research Partners and Republican pollster Ashlee Rich Stephenson for WPA Intelligence. They compiled opinions from 1,000 respondents. The data shows Americans, from both major political parties, overwhelmingly support measures to limit partisan gerrymandering.

The results include:

- An overwhelming majority (71 to 15 percent) of Americans want the Supreme Court to place limits on lawmakers' ability to manipulate voting maps.
- By a margin of 62 to 10 percent, voters are less likely to support a candidate who supports partisan gerrymandering.
- By a margin of 73 to 14 percent, voters support removing partisan bias from redistricting, even if it means their preferred political party will win fewer seats.

On Oct. 3, the U.S. Supreme Court will hear oral arguments in Gill v. Whitford, a case in which the justices have the opportunity to set a standard to determine what constitutes an extreme partisan gerrymander.

A majority of the U.S. Supreme Court has already found, on more than one occasion, that partisan gerrymandering is constitutionally problematic. In the past, the Court has not been willing to overturn a mapping scheme because there wasn't a workable test to assess the severity of the gerrymander.

This poll underscores that voters overwhelmingly expect free and fair elections for choosing their representatives.

## "MAYBE YES, MAYBE NO: OUR DEMOCRACY HANGS IN THE BALANCE"

On Tuesday morning, the Supreme Court heard what we hope will be the historic case of Gill v. Whitford. Why historic? Because the case represents the last chance, probably for decades, for the Court to rule that excessive partisan gerrymandering violates the Constitution. The League filed an amicus curiae brief in the case and we dearly hope that the Court blocks partisan gerrymandering. It could be a decision as important for democratic government as the "one person – one vote" decision that brought fundamental change to state legislatures and revolutionized American politics.

First, a little background: The last time the Court considered a partisan gerrymandering case was more than a decade ago in the case of Vieth v. Jubelier. The Court divided 4-1-4, with four Justices willing to overturn a Pennsylvania partisan redistricting plan and four opposed. The deciding vote belonged to Justice Anthony Kennedy, who agreed that excessive partisan redistricting could violate the Constitution but said he couldn't find a standard by which to judge when a plan was excessively partisan. He also suggested that the First Amendment's associational and free speech rights might be a better basis for overruling partisan

gerrymandering than the Equal Protection argument traditionally used.

Then came the Wisconsin legislature. After taking control of both houses and the Governor's mansion in 2010, Republicans produced a redistricting plan that is the most partisan observers have ever seen. And they did it on purpose, using computer programs and all the tools of our modern age. Moreover, they repeatedly fine-tuned the plan, not only to ensure a Republican majority in the next election, but to achieve a majority in the legislature for a full decade, no matter how the voters voted.

Gill v. Whitford is the challenge to this partisan redistricting plan. Plaintiffs argue that the plan does violate the First Amendment as well as the Equal Protection clause. And they used a new formulation that could provide a standard for courts to use. This is the "efficiency gap," which measures the extent of "packing and cracking" -- the practice of concentrating the other party's voters in just a few districts or distributing them so widely that their votes don't affect the outcome – as well as partisan symmetry – whether each party would win the same number of seats if each received a certain number of votes.
