For the first time in several years, Lunch & Learn met on October 11 in the Friends Room of the Columbia Public Library! We will continue to do so through May. (Zoom option is also available; register at https://events.dbrl.org/event/9020824).

Our November 8 Lunch & Learn program will be at noon at the library and via Zoom. It will feature Steve Hunt, Manager of the City of Columbia's Solid Waste Utility, who will talk about solid waste and recycling in Columbia and answer your questions.

Many thanks to Kathy Kiely, the Lee Hills Chair in Free Press Studies at the MU School of Journalism, whose excellent October program addressed the "50th Anniversary of the Missouri Sunshine Law, a Cornerstone of Democracy." She covered the bipartisan history and origins of our Freedom of Information Act (aka Sunshine Law), why it was so desperately needed, how it

is used to keep the public informed about government actions, and potential changes that could dilute the law. This event was the annual Holly Burgess Public Policy Forum, cosponsored by the LWVCBC, the Columbia Public Library, and the American Association of University Women (AAUW)-Columbia Branch. In August and September alone, 467 individuals engaged with our website. It took a lot of smart, caring people to make all that happen!

This *Voter* issue highlights some of the great work done in October, including our participation in the MU homecoming parade. The LWVMO Fall Conference will take place here in Columbia on November 4, and I'm sure we'll learn a lot and get fired up and ready to head into 2024. The November 8 Lunch & Learn will be about Columbia's waste disposal and recycling, which is always a hot topic. Finally, please mark your calendars for the annual Founders Day social event and awards ceremony, to be held on the afternoon of December 10. More details to come soon.

ENERGY AND CLIMATE UPDATE

The Climate and Energy Committee is focused on getting the City Council to Vote to have 100% Renewable Energy by 2030. The LWVCBC has worked on this with the Sierra Club, Renew Mo., and others for many months. In the last month, we have met with City Council Members individually to advocate and explain how this is realistically achievable.

There will be a work session before the City Council Meeting on Nov. 20th. It is open to the Public, and we encourage our Members to attend. (The Public will not be able to speak at this work session, but attending will be informative and educational, and your presence

there to show concern and support will be helpful). We will email all LWVCBC Members the week before this meeting with more details.

Our Lunch & Learn Program in December will focus on how the City can and should achieve 100% renewable energy by 2030 and what you can do to make this happen. Guest Speakers will be Carolyn Amparan of the Sierra Club and Mark Haim of Peaceworks. Keep posted, as we will need your support and involvement to make this happen!

We are now posting on Facebook Groups, Facebook Pages, Instagram, and X/Twitter. DID YOU KNOW? HERE'S HOW YOUR CHARITABLE DONATION CAN HELP THE LWV OF COLUMBIA & BOONE COUNTY

Are you planning for year-end charitable donations? We want you to know that donations to the LWV Missouri Education Fund can be earmarked for our local league account. The Ed Fund is a 501(c)3 charitable organization, so contributions are tax-deductible.

Besides regular donations, if you are 72 or older and required to take a minimum distribution from a retirement account, you can donate these funds tax-free directly from your retirement account to the Education Fund. Accounts that qualify for direct, tax-free distributions include IRA, 401(k), and 403(b). This is called a "qualified charitable distribution" or QCD. The QCD can be a portion (or all) of your required minimum distribution. Your investment adviser can give you more information about QCDs.

You can arrange with your investment adviser to have the contributions sent directly from your retirement account to the LWV Education Fund.

These contributions should be sent to the address below. Please clearly note that these funds sent to the Education Fund are earmarked for LWV Columbia/Boone County. Our League can then draw on the funds to support educational activities such as ads for voter education programs and printing of cards and brochures.
