### PRESIDENT'S MESSAGE

As I write this, we're enjoying a welcome thaw after weeks of icy weather. It's a good thing spring isn't too far away! The beginning of the presidential primary season is a powerful signal that 2024 will be a very active year for the League.

A recent commentary in the Missouri Independent is an inspiring reminder of the important role LWV plays in election years. The headline is "My best advice to voters in 2024: Focus on policy and the stakes, not the political circus." The author, David DeWitt, stresses that this is a time for voters to hold our elected officials accountable. He describes our democracy as "an exercise in collective self-government under the rule of law." His bottom-line advice is to "Focus on policy, focus on real-world outcomes, and focus on the stakes of power across all of our levels and branches of government."

That's exactly what LWV aims to do by providing unbiased voter services, nonpartisan forums for elected officials and aspiring candidates to articulate their goals and plans, and voter education materials about candidates and ballot issues. Each year we meet to weigh League positions on policy issues and prioritize advocacy efforts based on members' research and discussion. To participate, you're invited to join the February 13 LWVUS Program Planning meeting. See page three for information.

LWVUS has had a firm, succinct policy position on reproductive freedom since 1983: "Protect the constitutional right of privacy of the individual to make reproductive choices." The Missouri initiative petition for reproductive freedom will be available soon, so we'll soon provide details about opportunities to sign and help circulate it.

The February events calendar is full, starting with a February 8 forum with our current Boone County legislators. The February 15 Lunch and Learn will shed light on conspiracy theories (note it's a different time and day of the week than usual). And don't miss the kickoff of the When She Votes coalition on February 24! This inspiring event, co-sponsored by LWV-CBC, will help us focus on the real-world impact of voting on people's lives.

To quote David DeWitt one more time, "It's long, slow, hard, and crucial work, to pass down a country to future generations better than how we found it." That's what our forebears in the League did, so let's keep working at it.

## **LWVUS PROGRAM PLANNING MEETING ON FEBRUARY 13**

LWVUS will hold its 2024 Convention in June. As preparation for the convention, all local Leagues are asked to provide input on the work of LWVUS for 2024-26.

The main priority of LWVUS has been Making Democracy Work® which includes voting rights, improving elections, redistricting, and money in politics. Our League needs to decide if we support continuing the priority of Making Democracy Work.® If we do not support this priority, we would need to propose a different priority. Local Leagues can also propose a concurrence with a local position or propose a new study on a policy issue that is not covered in Impact on Issues.

Local Leagues are asked to report on their work during 2022-2024 using LWVUS positions. We will review LWVUS' Impact on Issues (<a href="https://www.lwv.org/impact-issues">https://www.lwv.org/impact-issues</a>) positions and report on any positions we have used in our work from 2022-2024. This is important and essential work for the League of Women Voters.

Here is how LWVUS describes our mission and membership:

The League of Women Voters is a nonpartisan, grassroots organization working to protect and expand voting rights and

ensure everyone is represented in our democracy. We empower voters and defend democracy through **advocacy**, **education**, and **litigation**, at the local, state, and national levels.

LWV members are passionate activists who support LWVUS work in all 50 states and in more than 700 communities.

After local Leagues submit their reports,

LWVUS will consider all the responses from Leagues throughout the country (300 local Leagues submitted responses in 2022). The National Board will then make recommendations to the convention, where delegates will debate and vote on the final program and any new concurrences or studies proposed by local Leagues. This process is why we are called a "grassroots" organization!

Our LWVUS Program Planning Meeting will be on Tuesday, February 13, at 6:30 p.m. on Zoom. A link will be sent to all members. This is a great time to appreciate the work we do and the part we play with LWVUS.

## APRIL 2ND ELECTION CANDIDATE AND BALLOT ISSUE FORUM WILL BE MARCH 21

The LWV has scheduled an election forum featuring candidates in contested races, a recall vote on Ward 1 Councilman, and a Boone County ballot issue on Thursday, March 21, at 6:30 p.m. at the Columbia Public Library (with a virtual option). David Lile will moderate the forum.

The April 2 Election will feature contested races for Columbia City Council Ward 2 and Columbia School Board. In addition, Ward 1 will vote on whether to recall Councilman Nick Knoth.

The Boone County Commission has voted to put the following issue on the April 2nd Ballot:

Proposition 1: "Shall the County of Boone exempt senior citizens from certain increases in the property tax liability due on such senior citizens' primary residences?"

Here is our schedule for the forum:

- Ward 1 Recall Vote with Nick Knoth and a representative from the Recall Group
- Ward 2 Candidates Lisa Meyer and Robert Schreiber
- Columbia School Board Candidates Jeanne Snodgrass, Alvin Cobbins, and John Potter (for two positions on the Board)
- Proposition 1 Speakers

Betsy Peters is running unopposed in Ward 6. She will be at the forum and available to talk to voters in her Ward.

The League is planning to have a digital Voters Guide available in mid-March.

## FROM THE LWV BLOG: WHAT LWVUS IS DOING ABOUT AI AND DISINFORMATION

The League is closely monitoring Al's potential impacts on our elections. In October 2023, the League supported a petition to the Federal Election Commission (FEC), arguing that the FEC should regulate "Deceptive Al Campaign Communications" like other deceptive campaign communications. LWVUS urged the Commission to heed the requests in the petition and issue explicit guidance that deceptive Al campaign communications meet the definition of "fraudulent misrepresentation" according to the US Legal Code.

The League's positions on a citizen's right to know, citizen participation, and campaign finance apply to the issue of deceptive AI; voters deserve access to true and complete information about elections and the candidates seeking their votes. The League is concerned that deliberately false, AI-generated content in campaign ads or other communications will undermine the role of voters and corrupt the election process by attempting to deceitfully sway voters' opinions or suppress voter turnout through misinformation about election rules.
